### **Meeting Called to Order**

The Mayor called the meeting to order.

### **Approval of Minutes of October 7th, 2014, Investments, and Department Reports**

A motion was made by Alderman Dawkins, seconded by Alderwoman Blalock, and unanimously carried to approve the minutes, investments, and department reports.

### **Public Comment**

The Mayor opened the public comment period.

Ms. Dawn Ingram, 5 Bradsher Court, thanked the city for the recent paving of her street.

There being no one further wishing to speak, the Mayor closed the public comment period.

### **Recognition of Community Group**

Mr. Randy Bazhaw with Scout Troop 532 was recognized for his contributions to the construction of a pedestrian bridge at the Deep River Nature Trail. The bridge will connect the two parking areas and is the first step in carrying the greenway down the river.

### **Amendment to Street Paving**

Sharp Brothers completed a selection of streets that were in need of repair. The paving bid was under what was estimated, therefore, it was requested to add the additional streets listed below to be paved:

Shaw St. (Main St. to Hammond)

Hammond St.

Worthville St. (Upton St. to E. Brown St.)

Upton St. (top 40 feet)

East Brown St. (Main St. to Worthville St.)

A motion was made by Alderwoman Blalock, seconded by Alderman Dawkins, and unanimously carried to amend the street paving contract to include the above streets.

### **Commerce Square Alcohol Policy Discussion**

As the public begins to use Commerce Square for festivals, fundraisers, weddings, vending, etc., issues have arisen related to the sale of alcohol and the city's own alcohol policy.

The Board was asked to give some thought as to what should or should not be allowed so that a coherent policy can be presented for adoption.

### **Parks & Recreation Citizen Input**

The city is conducting a community survey to update/create master plans. Community involvement is important to find out what facilities/programs the citizens want. The community survey requires resident participation and interdepartmental cooperation. Funding assistance is on the horizon, but the plans need to be enhanced first.

### **Manager's Report**

Nick Holcomb reported on the following items:
